### ✓ Global Advocacy to Elevate the Business Voice on AMR

Advance coordinated industry positions through the Multi-Stakeholder Platform on AMR

Engage in key global moments, including the High-Level Ministerial Meeting, WHA, and UNGA

Direct outreach to governments and other stakeholders to shape policy discussions

### ✓ Responsible Manufacturing & Adherence to Standards

Advance implementation of the Alliance manufacturing standard via independent BSI certification

Promote responsible manufacturing as a core expectation across the antibiotic value chain

Advocate for inclusion of manufacturing standards within procurement models
